



Leaving a gift in your Will to Australian Cancer Research Foundation (ACRF)

FREQUENTLY ASKED QUESTIONS

Q How do I make or change my Will to include a gift to Australian Cancer Research Foundation?

Your solicitor or trustee company can help you create or amend your Will to reflect your wishes. It's a simple process. With a codicil, you can also easily make small updates to your Will without rewriting the original document.

Q Can I ensure my family is cared for first?

Absolutely. One way is by leaving a residual gift, or a portion of your estate after you've provided for the people you love. It allows you to look after those closest to you and leave a gift that will help bring brilliant cancer research breakthroughs to millions of people who will need them in the future.

Q What types of gifts can I leave?

Whole Estate – where you leave your entire estate to ACRF. Those without dependents are choosing this exceptionally generous option.

Percentage gift – when you leave a percentage of your estate's overall value.

Residual gift – where you leave a portion of the residue of your estate, after covering expenses and providing for loved ones. Both residual and percentage gifts allow for growth in your estate's value.

Pecuniary gift – when you choose to leave a specific amount of money to ACRF.

A gift – where you specify an item, such as real estate or shares.

Q I know what gift I want to leave, and my estate isn't complex. Can I write my Will myself?

I direct that the receipt of any director or other proper officer for the time being of that Foundation will be a sufficient discharge to my Trustees."
